Company History

- **1928**
Maffei builds the first peeler centrifuge, which is followed in 1933 by the pendulum centrifuge. They mark the beginning of process technology at Krauss-Maffei.
- **1950**
Presentation of the first Krauss-Maffei Pusher Centrifuge at ACHEMA
- **1987**
The divisions of Krauss-Maffei AG are formed into separate operating companies.
(Krauss-Maffei Verfahrenstechnik GmbH)
- **1994**
Presentation of the first Krauss-Maffei Peeler Centrifuge in Pharma design
- **2000**
First contact-free sensor system for peeler centrifuges with reference measurement.
Presentation of the largest Krauss-Maffei Pusher Centrifuge SZ 500 with mechanical pusher drive.
- **2001**
Management Buy-Out by a group of management executives, total independence from Krauss-Maffei Group and reformed into **Krauss-Maffei Process Technology AG**
- **2003**
Presentation of the new Krauss-Maffei Vertical Centrifuge, new Mixer Dryer.
- **2004**
Upgrading of the Krauss-Maffei Plate Dryer and expansion of the Krauss-Maffei line of pusher centrifuges
- **2005**
Enlargement of the product range by adding mixer dryers with helical mixer in mobile and stationary design, pressure and vacuum filters for applications in the fine chemicals industry
- **2005**
Renamed **KMPT AG**
- **2006**
Move to Vierkirchen near Munich
- Launch of largest pusher centrifuge in the world, Krauss-Maffei Pusher Centrifuge SZ 1250.
- **2007** Launch of innovative membrane filtration by invention of Dynamic Crossflow Filtration.
- **2008**
Rewarded for the successful implementation and direction of a certification system over a period of more than 10 years by LRQA (Lloyd's Register Quality Assurance).
- **2010**
Acquisition of KMPT by ANDRITZ and change of corporate form to **ANDRITZ KMPT GmbH**
